Committee Background

- Legislation passed July 27, 2006; signed into law Aug. 16, 2006
- Legislation established Waterfront Access Study Committee (WASC)
- WASC "shall study the degree of loss and potential loss of the diversity of uses ... and how these losses impact access to the public trust waters of the state."

Committee Approach & Activities

 Full committee business meetings
Staffed and facilitated by NC Sea Grant and the NC Coastal Resources Law, Planning and Policy Center (CRLPPC), under contract with the N.C. General Assembly

Public Hearings

WASC Recommendations

- Retaining & enhancing working waterfronts
- Enhancing public access to coastal waters

WASC Recommendations

- Provide help in meeting environmental compliance costs
- Comprehensive socioeconomic study
- Cooperative state-local partnerships / approaches

- Further study and oversight

Working Waterfronts

- Extend present use value eligibility to working waterfronts
- Establish a working waterfront trust fund, or other separate set-aside of State funds

Endorse NC DENR One NC Naturally Program, particularly its development of a GIS-based database and model to identify working lands, including working waterfronts

Fund existing NCWRC Boating Infrastructure Program at significantly higher levels, giving priority to coastal public trust water access

Endorse joint NCWRC-NCDOT efforts to address public access in infrastructural programs

- Fund existing NCDCM Beach & Coastal Waterfront Access Programs at significantly higher levels
- Urge NCDWR's Water Resources Development Grant Program to give greater priority to applications seeking enhanced public access to coastal waters; urge State to fund program at higher levels

Allocate a reasonable share of new CRFL proceeds to public fishing access enhancements

Support the Joint Legislative Commission on Land and Water Conservation proposal to allocate \$1B over 5 years for conservation, cultural and historic preservation activities

Elevate public recreational access enhancement as a criteria for awarding of grants through the State's Clean Water Management Trust Fund

Require state coastal resource management agencies to catalog / prioritize waterfront site needs

Planning / Zoning Approaches

Under State CAMA, require local governments to inventory / assess / develop policies regarding working waterfronts

Provide additional funding via existing NCDCM Planning and Management Grant Program for local government public access inventories / plans

Planning / Zoning Approaches

Amend State CAMA to authorize provision of grants to local governments to inventory / plan for retention / enhancement of working waterfronts

Urge local governments to explore potential use of specialized zoning techniques, such as conditional zoning

Purchase / Transfer of Development Rights

Urge enacting legislation to authorize Purchase Development Rights and **Transfer Development Rights at the** local level for use in working waterfront and public access retention and enhancement programs

Fishing Piers

Grant present use value taxation eligibility to private commercial fishing piers (that provide public access)

Assist fishing piers owners with storm damage repair, such as through lowinterest loans secured by the proposed trust fund or set-aside

Fishing Piers

Authorize and fund the NC Aquariums to pilot the design / development / operation of three public fishing piers to provide both public angling access and public educational opportunities

Public Trust Submerged Lands

- Explore new means to generate a source of State revenues for working waterfronts and public access
- Re-examine and reformulate the State's public trust submerged lands easement fee structure as means to create revenues for access development

Public Trust Submerged Lands

Examine the nature and legality of long-term or permanent sale of docks or "dockominiums" that occupy public trust submerged lands

Environmental Compliance Costs

Make funds available to assist working waterfront and public access facility sponsors in developing or redeveloping facilities in ways that are fully compliant with environmental regulations

Socioeconomic Study

Provide funding for a comprehensive socioeconomic study of working waterfronts and access to coastal public trust waters

State-Local Partnerships

Encourage the establishment of locally based working waterfront and public access advisory bodies, with appropriate ex-officio State representation

Educational Outreach

Support educational outreach programs to improve retention and enhancement of working waterfront and public access to coastal waters

Study and Oversight

Establish a formal joint legislative commission that continues to study and guide working waterfront and public access programs
