NEP Coastal Watersheds Grant Program Announced

Restore America's Estuaries, in close coordination with and financial support from EPA, is administering the NEP Coastal Watersheds Grant Program. This grant program funds projects within the geographic boundaries of the 28 National Estuary Programs, including the Albemarle-Pamlico watershed. The NEP Coastal Watersheds Grant Program is a nationally competitive grant program designed to support projects that address urgent and challenging issues threatening the well-being of coastal areas within Congressionally-designated "estuaries of national significance." SAV Spotlight: 2020 Aerial Mapping Underway



North Carolina's high-salinity submerged aquatic vegetation habitat in our estuary. This data, combined with imagery from 2019 flights, will be used to create the state's third SAV map. These maps will allow APNEP and partners to better understand whether SAV, a vital fish habitat and indicator of water quality, is in a long-term decline in the Albemarle-Pamlico region.

APNEP Meeting Updates

May 11: The Coastal Habitat Protection Plan Steering Committee met on May 11. This Steering Committee is comprised of two members from each of North Carolina's three regulatory commissions with coastal jurisdictions. The committee received presentations from several agency staff regarding progress with the 2021 Coastal Habitat Protection Plan (CHPP), and a review of the progress made in implementing the 2016 Plan. Presentations on the new NC Marine Debris Actions Plan, on Virginia's successes and challenges to restoring oyster populations, and an update on the Blue Crab Fishery Management Plan and water quality issues which will need to be addressed in the 2021 CHPP.

May 20: The APNEP Leadership Council met to discuss APNEP's 2020-21 Annual Work Plan and continued refinement of focus areas for the program. APNEP staff continue to follow up on directives from the January 2020 Leadership Council meeting, including exploring opportunities to partner with local governments.
