

### Management plan for NC's aquatic invasive species is reinvigorated

APNEP staff have been working with the NC Department of Environmental Quality to advance North Carolina's Aquatic Nuisance Species (ANS) Management Plan, and this month the Plan's multiagency Steering Committee reconvened for the first time since 2016 to discuss needed updates as well as a timeline for getting an updated ANS Management Plan approved at the state and federal level. The Plan's approval will facilitate the coordination of numerous state and federal agencies, as well as NGO's, to tackle management and outreach of North Carolina's aquatic invasive species.

#### **APNEP Committee Updates**

- July 18th The joint APNEP/NC Coastal Federation <u>Oyster Habitat Restoration</u> Action Team met to discuss the NC Shellfish Initiative launch on August 2nd, as well as the purpose of the Team as it relates to the needs of APNEP and the NC Coastal Federation. A fully-vetted purpose statement will be decided on at the group's next meeting, which will likely be in January 2019.
- July 23rd The <u>Air Resources</u> Monitoring and Assessment Team convened to finalize their list of ecological indicators for APNEP's next <u>Ecosystem Assessment</u>.
- July 25th The joint APNEP/NC Coastal Federation Living Shorelines Steering Committee met for their kickoff meeting to discuss how regional groups can better collaborate on research, education, and incentives for sustainable management of estuarine shorelines. The committee will also be looking into how to best address and manage the invasive aquatic plant *Phragmites australis*.
- July 26th The Executive Board of APNEP's <u>Science & Technical Advisory</u> <u>Committee</u> met to discuss the group's 2018-2020 Action Plan and to decide on agenda priorities for the full STAC meeting on September 12th.
