Winners Selected: 2010 CAC Projects







The APNEP Citizens' Advisory Committee (CAC) has awarded \$118,022 in grants for seven projects that protect the environment and promote environmental education in parts of North Carolina and Virginia. Seventeen proposals for projects totaling \$302,148 were submitted to meet that challenge. The CAC grant program is designed to help increase awareness about the importance of significant natural resources in the Albemarle-Pamlico watershed and promote participation in its protection and restoration. This program is open to schools, non-profit organizations, businesses, and government agencies. To be funded, projects should have a positive impact on the Albemarle-Pamlico ecosystem and include a strong public education component. The selected projects will reach thousands of residents and visitors in the Albemarle-Pamlico region. Listed below are the seven organizations and their projects that will receive funding.

North Carolina

- The Mid-East Resource Conservation & Development Council was awarded \$19,800 for J.H. Rose High School's In-Stream Constructed Wetlands Schoolyard Demonstration Project. The grant will be used to plant a 0.75-acre constructed wetland, restore 450 linear feet of stream and provide educational programming at J.H. Rose High School in Greenville.
- N.C. Sea Grant was awarded \$20,000 for "Landscaping with Nature in Currituck County," a project that will create an environmental education demonstration site with natural landscape features and native plants at the Currituck County Cooperative Extension Building.
- The Black Family Land Trust in Durham was awarded \$20,000 for the Henderson Affordable Housing Wetland Boardwalk Trail. The grant will help create a protected, one-acre wetland park at the center of an affordable housing subdivision.
- The N.C. Division of Marine Fisheries was awarded \$8,087 to reduce stormwater flowing into Bogue Sound at the division's headquarters in Morehead City. This is part of a comprehensive stormwater project and will involve re-vegetating part of the Bogue Sound shoreline adjacent to the agency's headquarters and educating the community about stormwater pollution.
- The N.C. Coastal Reserve in Carteret County was awarded \$14,929 for the Carrot Island Habitat Improvement Demonstration Project. The project will improve a 22,000-square-foot dredge spoil habitat through native plantings and fencing and provide public outreach about habitat improvement.

Virginia

- **Dinwiddie Junior High School** in Dinwiddie, Va., was awarded \$15,206 for its Outdoor Classroom and Nature Trail. The grant will be used to construct an outdoor classroom area with seating, an educational kiosk and a nature trail with signs identifying native plant species.
- **Greensville County, Va.** was awarded \$20,000 for phase 1 of the Uriah Branch Nature Trail. The project will consist of trail development next to the Greensville County Government Complex and construction of an observation deck overlooking the floodplain and wetlands along Uriah Branch stream.

Welcome New Policy Board Leadership

The policy board provides community involvement, participation, and support to the Albemarle-Pamlico National Estuary Program (APNEP) on measures to restore and protect the significant resources of the Albemarle-Pamlico region. It was established by North Carolina Governor's Executive Order #74. The policy board works with each of the advisory committees (Citizens', Science and Technical and Management) to provide advice and support to the APNEP program office, its partners on implementation of the APNEP Comprehensive Conservation and Management Plan. The board also acts as a forum for the exchange of information on issues relevant to the APNEP watershed. APNEP's policy board elected a new chair and vice chair in March. Below is some information about our new leadership.



Tony Reevy, Chair

Tony Reevy is the senior associate director at the UNC Institute for the Environment (IE), which is the multidisciplinary program leading UNC-Chapel Hill's environmental community in educating practitioners, researching and solving global challenges and informing the public about critical issues. In his nearly 10 years at UNC, Reevy has helped guide the transition from the Carolina Environmental Program to IE, first as the program's chief development and public affairs officer, and more recently as its chief financial and administrative officer.

Prior to joining IE, Reevy was the director of library development at North Carolina State University. He previously held positions as the director of development at WFAE-FM in Charlotte, corporate relations manager at WAMU-FM in Washington, D.C., and others. In addition to his dedication to the environment, Reevy is also an accomplished creative writer, specializing in poetry, and a railroad historian. He has more than 100 publications, including two non-fiction books and four poetry chapbooks, and poems appearing in a number of anthologies. In addition to the Albemarle Pamlico National Estuary Program Policy Board, Reevy serves on the boards of directors of the Museum of Durham History, the Norfolk & Southern Historical Society and North Carolina Rail-Trails.

Reevy holds an MBA with a marketing specialty from UNC-Chapel Hill, an M.S. in Mass Communication from Miami University and a B.S. in Chemistry and Civil Engineering from N.C. State. He is married and has two children.



Eric Walberg, Vice Chair

Eric J. Walberg is the Administrator of the Physical and Environmental Planning Department of the Hampton Roads Planning District Commission (HRPDC) in Chesapeake, Virginia. His responsibilities include oversight of several urban and environmental planning initiatives and supervision of the department's planning and GIS staff. Walberg has been extensively involved in the development of a regional green infrastructure network in southeastern Virginia. He has been on the staff of the HRPDC for twelve years.

Prior to joining the HRPDC staff he was employed by the Department of Community Development in Charlottesville, VA where he was responsible for updating the Charlottesville Comprehensive Plan.

Walberg holds a Master of Planning degree in Urban and Environmental Planning from the University of Virginia, a Bachelor of Science degree in Computer Science from Old Dominion University and a Bachelor of Fine Arts degree from Virginia Commonwealth University. He is a member of the American Planning Association and the American Institute of Certified Planners.

Girl Scouts Go Green with Help from APNEP

APNEP and the Citizens' Monitoring Network have partnered with the Girl Scouts of America to assist girls in the completion of the Environmental Ambassadors badge. Girl scouts from around the region come together to spend the weekend learning about the importance of our environment, which ranges from tips on being "green" to aquatic ecology. Through our partnership, APNEP have instructed the girl scouts on the importance of water quality, conducting water quality tests, how pollution can travel downstream, effects on fish and native communities, and better alternatives for a "greener" environment. Girls in the environmental ambassador program will form their own "green teams" and conduct an environmental project in their local community later this year.

APNEP Director Speaks at Regional Climate Change Conference

APNEP Director Bill Crowell was recently invited by the Department of the Interior to speak at a workshop entitled "Adapting to Climate Change in the Mid-Atlantic." The goal of the workshop was to develop a common understanding of assessment techniques that determine potential climate change impacts to protected areas in the Mid-Atlantic United States and to explore adaptive management approaches that address those impacts.

Bill spoke about community engagement around climate change issues in the Albemarle-Pamlico estuarine region.

This intergovernmental workshop on climate change was held March 23-25 in Cambridge, Maryland for land, coastal and ocean area managers in the Mid-Atlantic United States. It was cosponsored by the Northeast Region of the U.S. Fish and Wildlife Service, the National Capital and the Northeast Regions of the National Park Service, the Eastern Region of the U.S. Geological Survey, U.S. Forest Service's Eastern Region and Northeastern Area, NOAA's Office of National Marine Sanctuaries, and the Minerals Management Service.
