While many of our partners are based in North Carolina, the Albemarle-Pamlico region also extends up into Virginia's "Southern Watersheds." Throughout 2018 we've worked to establish new partnerships and reinvigorate existing ones, building off the 2001 and 2017 Memorandums of Understanding APNEP has facilitated between NC and VA state environmental agencies. These MOUs represent a commitment by North Carolina and Virginia to working together to address issues in their shared river basins and have already led to new collaborations and opportunities. Virginia Governor Signs Executive Order to Bolster Coastal Resilience

On November 2nd, Virginia Governor Ralph Northam issued an <u>Executive Order</u> to increase Virginia's resilience to sea level rise and natural hazards. The Executive Order details actions that the Commonwealth will take to limit the impact of flooding, extreme weather events, and wildfires. Issues addressed by this EO intersect with North Carolina Governor Roy Cooper's recent <u>Executive Order</u> announcing North Carolina's transition to a clean energy economy and directing cabinet agencies to integrate climate mitigation and resiliency planning into their operations.


