Albemarle-Pamlico Estuarine Study Policy Committee Meeting August 31, 1989 Williamston, NC

Secretary Cobey called the meeting to order at 9:10 a.m. (Attendees list Attachment A)

I. Consideration of Minutes

Derb Carter moved to accept minutes of last meeting; Dr. Queen seconded the motion, and the motion was unanimously approved.

II. Director's Report - Dr. Bob Holman

Dr. Holman gave an update of the current status of the program (Attachment B).

During the discussion of the Consistency Report Milestone, it was agreed that Mr. DeHihns and Secretary Cobey would send a letter to EPA/OMEP stating that the A/P Study is unwilling to meet this milestone until it receives the necessary guidelines from EPA.

The committee discussed the Army Corp of Engineers involvement with the study. Bill Queen moved that the district engineer (COE) be invited to become a member of the Policy Committee and that he designate a representative to be a member of the Technical Committee. Mike Gantt seconded the motion, and the motion was unanimously approved. Co-chairs will extend the invitation.

III. Technical Committee (TC) Report - Dr. Ernie Carl

The Technical Committee meet on August 22 and various elements of the program were reviewed. The TC felt that the program was on track and no action by the Policy Committee (PC) is required. Dr. Carl noted there are four documents to be produced that must interact; the Milestones, Consistency Report, Status and Trends, and Comprehensive Conservation Management Plan (CCMP). Dr. Carl informed the Committee of some problems encountered with several deliverables/products. He stated this type of problem will be avoided during the next cycle of contract awards.

Bob Holman stated that the \$48,000 transfer approved by the PC from the data management budget was used to expand Dr. Noga's efforts on the Ulcerative Mycosis project. Dr. Holman said that approximately \$100,000 was saved during negotiations with researchers which was used to keep the USGS

monitoring effort going for this next year. Dr. Holman noted lacking funding is DEM's supplemental one area continuous monitoring with the monitoring In response to Bill Queen and Brewster Brown's concern of incomplete projects from previous years, Dr. Holman stated that proposals, including continuations, are reviewed yearly and contracts are written to cover situations where the Department may have to terminate a project.

Dr. Carl stated that the TC will take the lead in the development of the draft CCMP. Outside experts will be asked to review it. Derb Carter said that the milestones had the experts included as the draft was being developed. During this discussion it was stated that experts will be called upon for input as the draft is being developed. They will also be solicited to review the draft CCMP.

IV. Update of Milestones and Development of CCMP Outline:

The Standard Operating Procedures Subcommittee (SOP) developed the Milestones document. It was revised for further clarification and has been submitted to all other committee members. Dr. Holman repeated the procedures to be used in the development of the CCMP which had been previously discussed.

V. Citizens' Advisory Committees

Pamlico Citizen's Advisory Committee Report - Derb Carter

Mr. Carter said there were four existing vacancies on the PCAC due to resignations. The following four were named as replacements: Mr. Eddie Smith, Mr. Etles Henries, Dr. Vince and Dr. John Van Duyn. There was discussion regarding the designated areas of representation on the CACs. Dr. Holman and Mrs. Giordano were instructed to work with the chairmen in categorizing positions on each CAC and insuring correct replacements when vacancies occur. suggested that the categories be reviewed determine if the structure should be revised. Mr. Carter moved on behalf of PCAC that the four existing vacancies be filled by Mr. Smith, Mr. Henries, Dr. Bellis, and Mr. Van The motion was seconded by Don Bryan, and unanimously issue of geographic location was approved. The Mrs. Giordano was instructed to develop a form to discussed. pertinent data on each CAC candidate, include occupation, education, affiliation, location, etc. Carter made a motion to replace Mr. Fred Bonner (sport Neal Lewis fishing) and Mr. (tourism) based on their attendance record. Dan Ashe seconded the motion and the unanimously approved. The committee was discussed the established policy regarding attendance. was stated that the policy had not been strictly adhered to The CAC chairs were asked to enforce the in the past.



attendance policy. It was stated that a letter would go from the PC informing the members of their replacement. Mr. Carter stated that the committee is essentially making four recommendations for those 2 existing vacancies: Ms. Sharon Gibbs, Mr. Roy Fogle, Mr. Zeno Ratcliff, and Mr. Roger Maze. Mr. DeHihns moved to appoint to the PCAC Sharon Gibbs and Mr. Roy Fogle. Don Bryan seconded the motion, and the motion was unanimously approved.

<u>Albemarle Citizen's Advisory Committee Report - Dr. Parker</u> Chesson

Dr. Chesson noted that there are three existing vacancies on the ACAC and that five individuals were recommended at the last ACAC meeting. Dr. Chesson recommended that Paul Lilly, Shelby Mansfield, and Joe Hollowell be approved to fill the three vacancies on the ACAC. Lee DeHihns seconded the motion. The motion was unanimously approved. Dr. Holman and Mrs. Giordano were instructed to draft three letters for the PC co-chairs stating that the attendance policy will be enforced in the future and to include the attendance record Dr. Chesson announced his resignation as of each member. ACAC Chairman. Brewster Brown was congratulated on his election as ACAC Chairman. Mr. DeHihns proposed a resolution commending Dr. Chesson on his commitment to the A/P Study (Attachment C). Don Bryan made a motion for the unanimous adoption of the resolution which was seconded by Mr. Carter. The resolution was unanimously adopted.

VI. Update of Status and Trends Report - Dr. B. J. Copeland

Dr. Copeland gave a brief overview on the draft Status and Trends Report. He noted that there is considerably more information on the Pamlico Sound than the Albemarle. There is an obvious lack of synoptic analysis of the system. The Status and Trends Report is focusing on the same four areas addressed in the Work Plan: Critical Habitat, Fisheries, Water Quality, and Human Environment (Attachment D). Dr. Copeland said that the second draft of the Status and Trends will be sent out when completed, and he urged everyone to read it and contact him or the members of the working groups regarding their comments. There will not be another round of meetings held to discuss this second draft.

Dr. Holman emphasized that the draft Status and Trends Report is only preliminary and even though Dr. Copeland's work will be completed the end of October, the Status and Trends Report will still be in draft form. It was suggested that additional funding be sought during the FY 1990 funding cycle to develop the mechanism to be used in finalizing the Status and Trends Report.



VII. Special Announcement - Lee DeHihns

Lee DeHihns announced that Bruce Barrett who has been served as co-chairman of the Technical Committee will be stepping down as the EPA Water Management Division Director in Atlanta. Mr. DeHihns has asked Mr. Bowman Crum to sit temporarily in that position for EPA and also act as co-chair of the TC until a replacement is named.

VIII. Review Meeting Schedule

There was discussion on the meeting schedule for 1990. Dr. Holman stated that the February 27 and February 28 meetings will be moved to March 6 and March 7. The Call for Proposals will be sent out on November 22, 1989. Dr. Holman was asked to send the revised scheduled to all committee members.

VIII. Public Comments/Questions

Luther Daniels stated that the Status and Trends document will be very useful to him and expressed his thanks for the work which has gone into its development.

The Policy Committee will meet on November 21, 1989, at a place to be announced. The meeting adjourned at 12:45 p.m.
