



Hi Folks:

Enclosed are the minutes from the CRBRC meeting held on April 4, 2002. Thanks to Chad Prior for doing such a fine job of capturing meeting activity!

I have also enclosed a letter from George Norris, a watershed planner with the Wetlands Restoration Program within the NC Division of Water Quality. While his letter is self-explanatory, I'd like to underscore the importance of his request, particularly in light of NC budget woes and staff's inability to travel.

Over the years, through your association with the Albemarle-Pamlico National Estuary Program (APNEP), I know you are most aware of the need to preserve, protect and where necessary, restore the beautiful and valuable natural resources of eastern NC. This is accomplished through your membership on the CRBRC, your involvement in the development of the Basinwide Water Quality Plans, and your attendance at environmentally relevant regional public meetings.



The Chowan River Basinwide Wetlands and Riparian Restoration Plan is an important document that targets areas in need of attention and where restoration projects are most likely to yield the greatest benefit. Because fiscal constraints presently prohibit in-person solicitation of your input for plan update, I'm asking that you seriously consider the enclosed and respond accordingly.

MINUTES

Chairperson Marjorie Rayburn called the meeting to order. The following folks were in attendance: Chairperson Marjorie Rayburn, Billy Griffin-NCCES, John Stallings-S&WCD, Roger Spivey-Chowan County Silvaculture, G.D. Perry-Bertie County Farmer, Chad Prior-Nucor Steel and Allen Clark-APNEP/CWQMP

The minutes from the February 7, 2002 meeting were approved. Motion made by John Stallings and seconded by Roger Spivey.

Presentation given by Allen Clark - Citizens Water Quality Monitoring Program Coordinator. Allen gave handouts of his presentation. He described the program, its inception in 1988 w/ the Tar-Pamlico River Foundation to current program, area covers 30,000 square miles, 9,300 miles of streams, 1.8 million acres of brackish, majority of watershed is in Virginia.

Benefits of water quality monitoring are

awareness/education/alertness to regulatory folks-programs, volunteers, family, friends and passersby. Volunteers monitor weekly from April 1 to October 15 each year and then monthly from October 16 to March 31 each year. Retirees make up the largest portion of volunteers with community

groups, college science classes and elementary/secondary schools.

Variables monitored include: pH, air/water temperature, salinity/conductivity, dissolved oxygen, turbidity, depth of water, secchi depth, and visual observations. Chlorophyll a, phosphates, and nitrates are measured in the Chowan River only. For better consistency, sampling should be conducted at the same time and day each week. Instruments utilized do not require calibration. Therefore, they are very easy to use.

Areas that need more monitoring are the Potecasi Creek and Turkey Creek. Areas need to have safe access, close to home or location for ease.

Allen believes that overall the water quality has improved, even though the fish population is down from historical levels. Allen is located at ECU at (252) 328–1747 if anyone is interested or has questions.

Roger Spivey brought up that better communication in newspapers about facts of water quality not just fish kills needs to be conducted. It could be similar to the Forestry scale from 1-7 (none to severe burn days). There is a website for CWQMP, but long delay on updated information. To discuss with Joan to see about possibilities of getting better communication along with background information.

Announcement of public meeting for draft Chowan River Basinwide Management Plan to be held on May 14, 2002 from 6-8pm at the Roanoke Chowan Community College. Jennifer Everett is the new basinwide water quality planner who was hired for the position vacated by Kate Moore. Copies of the

SUBJECT: DRAFT Targeted Local Watershed Selections for the Chowan River Basin

As part of the North Carolina Wetlands Restoration Program's (NCWRP) effort to update the 1998 Basinwide Wetlands and Riparian Restoration Plan for the Chowan River Basin, NCWRP Watershed Planners are identifying Targeted Local Watersheds within the Basin. This memo is to solicit your comments and recommendations regarding our Draft picks for Targeted Local Watersheds.

Targeted Local Watersheds (TLWs) are 14-digit hydrologic units where restoration projects are likely to be most effective in improving and protecting water quality [and other vital watershed functions such as flood control and aquatic habitat]. At this scale, the NCWRP can best focus its resources for stream, riparian buffer, and wetlands restoration projects within local watersheds. The basic criteria we use to target these local watersheds are whether they have (a) the **need** for restoration [e.g., declining or impaired water quality or habitat]; and (b) the **opportunity** for cost-effective restoration projects [e.g., potential collaboration with local government and/or existing project efforts].

The NCWRP has in the past held meetings in the Basin to solicit local input on the update of the basin's Watershed Restoration Plan -- including potential TLW selections, revised goals and objectives, and potential restoration opportunities. Due to budget concerns, we would prefer at this time to solicit input in writing and by telephone as opposed to holding meetings. We have enclosed maps and information outlining the first cut of draft TLWs, and hope in this way to encourage feedback and ideas from those of you out in the field who might have specific local knowledge to add to the selection process.

The NCWRP is currently compiling and reviewing water quality, land use, and sensitive resource information for the Chowan River Basin including information obtained from public workshops held by the NC Division of Water Quality in March of 2001. Our basic goals are to identify high-priority TLWs within the Chowan River basin and to identify potential candidate sites for wetlands, stream, and riparian buffer restoration projects. Targeted Local Watersheds are also selected on the basis of Future restoration need and opportunity within the basin. While the NCWRP currently has compensatory mitigation payments in the fund for restoration projects within certain areas within the Chowan Basin, we are also identifying areas that will be appropriate for restoration in the event future mitigation needs are incurred in other areas of the basin.

The DRAFT Targeted Local Watersheds selected for the Chowan River Basin are listed below.

It is anticipated that additional information to support the selection of some of these TLWs will be obtained during field visits to certain local watershed sites planned for the next few months. <u>Note</u>: we would like to visit existing and potential stream or wetland restoration sites in the area over the next few months. Anyone interested in such a field trip and/or who has candidate restoration sites in mind should contact George Norris at the number given below at your earliest convenience.

If you have reasons to encourage the NCWRP to retain a Targeted Local Watershed listed, please provide those comments. On the other hand, if you disagree with any of the Targeted Local Watersheds listed or have additional information on areas not identified but of concern, again we ask for your comments and recommendations. Your comments will be considered in selecting the FINAL Targeted Local Watersheds for the 2002 Watershed Restoration Plan for the Chowan Basin. These FINAL selections represent those areas where the NCWRP's resources for restoration projects will be focused over the next four years, contingent upon the availability of restoration funds. In addition, the NCWRP hopes that these local watershed selections can help foster collaborative watershed restoration efforts between government and non-profit groups working on restoration activities in the basin.

The deadline for providing comments to us on these Targeted Local Watershed selections is June 7, 2002.
