**Minutes**

Secretary Jeff Furness called the meeting to order at 10:05 a.m. Joan Giordano called the roll, and then self-introductions were made. There were nine members present, plus two Division of Water Quality staff. A motion was made to accept the minutes from the December 6, 1999 meeting in Rocky Mount, seconded and passed.

The first item discussed was the need to develop another idea for a demonstration project. The Warren County pasture aeration project has been shelved. Bruce Perkinson, the coordinator of the project, and former TRBCRC member, has resigned his position with Warren County. Therefore the project will not be initiated. We have approximately \$10,000 to use on another project.

Two project ideas were briefly explored. First was on duckweed research in hog lagoons. Larry Odom will provide an article on the subject to Joan Giordano. Secondly, Rob Perks informed the group of an existing NE Tar Heel Land Conservancy project, headed by Tom Bean, working with landowners installing BMPs to reduce sedimentation in the upper Tar River Basin. Rob will contact Tom Bean to get the details. The contract for Dr. David Lindbo's alternative septic system demonstration project is ready to be signed, and the contract will start May 1, 2000.

During the Nominating Committee report, it was stated that Mary Jane Jennings has not been feeling well, and no activity has occurred as far as nominations for new officers.

Under new business, Joan Giordano said that if anyone knows of a person in their county that could fill an interest-group position on the council, please let her know.

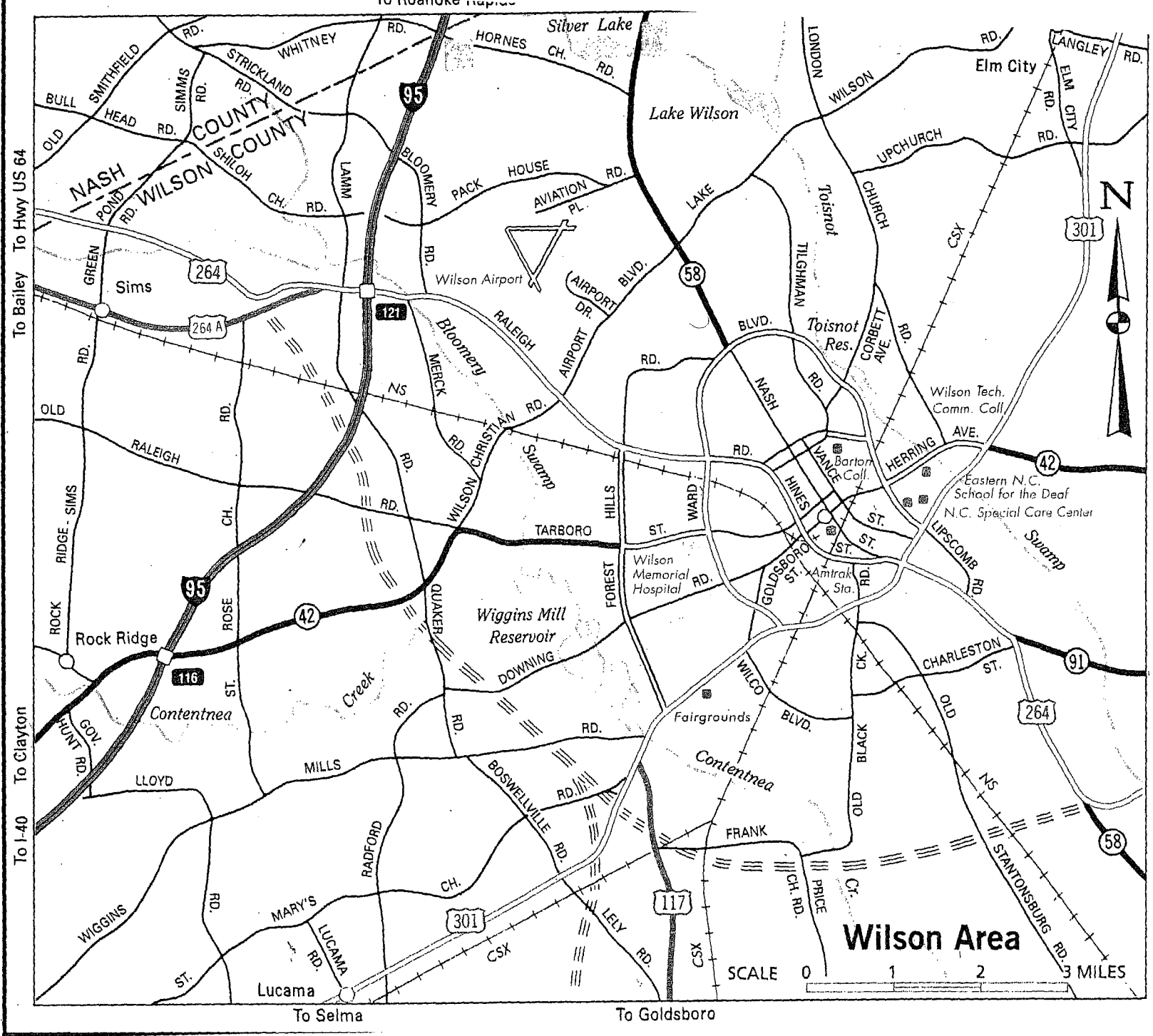
Other new business included a decision to follow the Neuse Council's lead and bring photos, video, or descriptions of either the most beautiful or the ugliest sites in the Tar-Pamlico basin, to the next meeting. These sites may be publicized in some form or other.

Plans for the next meeting include discussing the two or more ideas for a demonstration project, trying to schedule a presentation on last year's flooding by a representative of the USGS, and possibly voting on new officers. There being no further business the meeting was adjourned.
