

Army Corps Changes Wetlands Rules

WASHINGTON -- To conservationists, new government regulations on wetlands will allow homebuilders to put up single-family dwellings in flood plains and reroute miles of narrow streams. For developers, the Army Corps of Engineers' reduced requirements for speedy government approval of draining and filling permits is a long-overdue relaxation of changes ordered by Congress.

The regulations, announced Monday, revoke some requirements for winning expedited permits that the Clinton administration imposed on developers during its last year in office.

The rules were adopted without formal comment from the Interior Department, despite objections to several of the measures by the department's Fish and Wildlife Service. Its protests were not forwarded to the corps, said department spokesman Mark Pfeifle, and Interior Secretary Gale Norton sent word that she supported the new plan.

Instead of requiring acre-for-acre restoration on each project, for example, the new regulations state only that there be "no net loss" of wetlands in any of the corps' 38 U.S. districts, which are established on the basis of watersheds rather than state boundaries.

John Studt, chief of the corps' regulatory branch, said the new permit requirements "will do a better job of protecting aquatic ecosystems while simplifying some administrative burdens for the regulated public."

The National Association of Home Builders described the new permits as a positive first step, though it also said the process still was insufficiently streamlined. "This is the first time in the 25 years of the program that the corps has not added further limitations or more paperwork requirements," said Susan Asmus, a vice president for the group.

Left in place was a Clinton-era requirement that developers get a permit for any project involving more than a half-acre of wetlands. Until 2000, developers had to get government approval only if more than three acres of wetlands were affected. The new regulations eliminate some restrictions on development in flood plains and revoke a prohibition on filling more than 300 feet along any stream. Developers will be able to seek waivers allowing them to fill up to a half-acre of any stream that doesn't flow year-round.

"The inevitable result will be increased floods, more water pollution and greater loss of wildlife habitat," said Daniel Rosenberg, an attorney for Natural Resources Defense Council. Coal mines will have to get a written determination from a district engineer that dumping mine wastes in wetlands will have a minimal impact. Such fills will have to be replaced with new wetlands elsewhere.

The Fish and Wildlife Service complained in an Oct. 15 memo that the ecological effects of the changes had not been assessed adequately. The agency said it "does not believe the corps has sufficient scientific basis to claim" that the new, expedited permits will "cause only minimal impact on the nation's natural resources." Norton's staff "did not have enough time" to reconcile that memo with contrary remarks by the Office of Surface Mining, spokesman Pfeifle. Thus, no formal recommendation was made, he said.

PROPOSED RECLASSIFICATION OF SWIFT CREEK WATERSHED: PUBLIC HEARING SET FOR FEBRUARY

The N.C. Department of Environment and Natural Resources on behalf of the Environmental Management Commission (EMC) will conduct a public hearing in order to receive public comments on the proposed reclassification of a section of Swift Creek (Nash County) in the Tar-Pamlico River Basin to the ORW (Outstanding Resource Water) classification. In addition, it is proposed that the ORW special protection measures, or management strategy, be implemented throughout the watershed of Swift Creek (Edgecombe, Franklin, Nash, Vance, and Warren Counties, Tar-Pamlico River Basin).

GENERAL DEFINITION OF PROPOSED RECLASSIFICATION

The ORW designation is a classification intended to protect unique and special waters having excellent water quality and being of exceptional state or national ecological or recreational significance. To qualify, waters must be rated Excellent by DWQ, and have one of the following outstanding resource values: 1) outstanding fish habitat or fisheries; 2) unusually high level of waterbased recreation; 3) some special designation such as N.C. or National Wild/Scenic/Natural/Recreational River, National Wildlife Refuge, etc.; 4) important component of state or national park or forest; or 5) special ecological or scientific significance (rare or endangered species habitat, research or educational areas).

BACKGROUND OF RECLASSIFICATION REQUEST

A request for reclassification of Swift Creek was submitted by the Pamlico-Tar River Foundation. The purpose of this rule change is to provide supplementary protection for the resources and quality of these waters. Water quality studies conducted in 1996 and 1997 indicate that only an approximately 14-mile segment of Swift Creek, which traverses from S.R. 1003 to S.R. 1004 in Nash County, has excellent water quality. In addition, these studies combined with additional data revealed that this segment contains many important species that carry a variety of State and federal designations. This segment contains the Tar River spiny mussel, which is a federally and State listed endangered species. Thus, based on the water quality and existing resource values, this Swift Creek segment qualifies for the ORW designation.

The remainder of the creek's watershed also contains several important resources. This area contains a variety of species that carry varying State and federal designations. The red cockaded woodpecker and dwarf wedgemussel, which are federally (and in the case of the woodpecker also State) listed as endangered, are located in this area, as are three natural heritage areas, four natural communities recognized by the Natural Heritage Program (NHP), a wading bird rookery, and a natural area registered with the NHP.

WATERS TO BE AFFECTED BY PROPOSED RECLASSIFICATION

Due to the presence of the resource values in the watershed and the excellent water quality of the 14-mile segment, it is proposed that the ORW special protection measures, or management strategy, be implemented throughout the entire Swift Creek watershed, but only the 14-mile segment actually receive the ORW classification. The current and proposed classification of the 14-mile portion is Class C NSW and Class C ORW NSW, respectively. The waters within the remainder of the creek's watershed currently carry a variety of classifications, and these waters are proposed to receive a "+" symbol in the schedule of classifications for the Tar-Pamlico River Basin to signify designation of only the ORW management strategy. Nearly 207 river miles exist within the area to be affected by this proposal.

PROPOSED RECLASSIFICATION REGULATIONS

If reclassified, regulations that affect new development activities, wastewater discharges, landfills, and DOT activities would apply. However, there are no proposed discharges or significant proposed development according to the 13 local governments with jurisdiction in the proposed reclassification area (the above-mentioned five counties and the following towns/cities: Whitakers, Leggett, Rocky Mount, Henderson, Red Oak, Castalia, Dortches, and Centerville). More specifically, only the staff with the Town of Whitakers mentioned one specific development project (a 37 home subdivision) which they are uncertain will ever occur. Forestry, animal, dam/resource, and agricultural practices will not be affected. Please also note that all new activities within 50 feet of NSW waters in the Tar-Pamlico River Basin are subject to the currently existing Tar-Pamlico Basin Riparian Buffer Protection rules.

HOW TO SUBMIT COMMENTS

The purpose of this announcement is to encourage those interested in this proposal to provide comments. You may either attend the public hearing and make relevant verbal comments, or submit written comments, data or other relevant information by March 7, 2002. The Hearing Officer may limit the length of time that you may speak at the public hearing, if necessary, so that all those who wish to speak may have an opportunity to do so.

The EMC is very interested in all comments pertaining to the proposed reclassification. All persons interested and potentially affected by the proposal are strongly encouraged to read this entire announcement and make comments on the proposed reclassification. The EMC may not adopt a rule that differs substantially from the text of the proposed rule published in the North Carolina Register unless the EMC publishes the text of the proposed different rule and accepts comments on the new text (see General Statute 150B 21.2 (g)). The proposed effective date for the final rule pursuant to this hearing process is April 1, 2003 pending EPA approval. 

Minutes

The meeting was called to order at 10:10 am by Vice-Chairman Paul Blount. Joan Giordano called the roll, and there were 12 members and 2 staff present. Joan introduced Mr. Norfleet (Fleet) Sugg, a new TPRBRC member from Pinetops, representing Edgecome County. The minutes from the October 19, 2001 meeting were moved to be accepted, and the motion was seconded and passed.

The meeting was then turned over to Dr. David Lindbo, Associate Professor of Soils with N.C. State University and the N.C. Cooperative Extension Service, based out of the Vernon James Research Center in Plymouth. Dr. Lindbo gave a PowerPoint presentation of "Evaluation of a Peat Biofilter Treatment System". He stated that the basic problems of septic systems in Eastern North Carolina are high water tables, high soil clay content, and lack of maintenance by homeowners.

Dr. Lindbo then described by drawings and photos the peat biofilter treatment system that he is researching. He currently has four systems in the ground in New Hanover, Dare and Gates Counties, and is the type of system that our Council has given him a grant to install somewhere in the lower Tar-Pamlico River Basin.

Next Dr. Lindbo presented the history and status of the Tar-Pamlico project. He found a homeowner contact in Pitt County in September 2000. The current septic system was failing with sewage sometimes appearing on the ground. It was a wet site and had a limited repair area. There was a controversy over who was responsible for the failure of the system, and the homeowner hired a lawyer and a consultant. Eventually it was resolved, and in the fall of 2001 a contractor bid the peat mound system for \$24,000. Our Council was going to pay \$8,000 toward the cost. In the last week or so, the homeowner has abandoned the project in favor of forcing the City of Greenville to extend sewer service to his area.

A discussion was then held to decide what the Council wanted to do regarding this alternative septic system grant. It was decided to ask Dr. Lindbo to proceed with haste in efforts to work with county health departments to locate another homeowner.

The next agenda item was an update on the N.C. Estuarium Wetland Exhibit project. Tom Stroud of the Estuarium staff has been in contact with an exhibit designer in Raleigh, and the exhibit is currently in the planning and design phase. PCS Phosphate has also given their \$5,000 pledge for the project.

During the public comment part of the meeting, items briefly discussed were the proposed reclassification of a part of Swift Creek in Nash County to ORW, and the new Corps of Engineers nationwide permit wetland rules.

The next meeting was set for March 22, possibly in Nashville. The meeting was adjourned at 12:25 pm.
