

#### Meeting Notes

The meeting was called to order by acting Chair, Clarence Skinner at 1:00pm. Self- introductions were made and a presentation by Jeff Brown, from the Center for Geographic Information and Analysis (CGIA), was made relative to a grant they received from the Clean Water Management Trust Fund (CWMTF). The grant is for the development of a water quality Geographic Information System (GIS) which will, among other things, help the CWMTF evaluate future applications for grant proposals. Mr. Brown was interested in learning about the water quality concerns and issues which were important to TPRBRC members so that the data used in their GIS data base would be inclusive.

Mr. Skinner then outlined the purpose of the TPRBRC. Briefly stated, he said "The purpose of our Regional Council is to make the water better in the Tar-Pamlico basin--make it able to support its uses and turn around degradation."

Suzanne-Skinner, DWQ, gave a brief presentation on the use of consensus vs. Majority vote for making RC decisions. She explained that the consensus method is time consuming, but that it greatly cut down on time consumption during the implementation phase. Discussion ensued and the group decided upon the use of the consensus as the method they preferred. (See draft bylaws enclosed).

Acting Chair Skinner asked that TPRBRC members send autobiographical sketches to Joan Giordano or Guy Stefanski so all RC members would be aware of who their co-members were. (See memo from Joan and Guy dated November 24, 1997.) It was felt that this was necessary preparatory to electing TPRBRC officers.

The meeting adjourned at 4:30pm with discussion of TPRBRC priority issues and concerns tabled for the next meeting. The next meeting is scheduled for Jan. 23, 1998, from 1:00-4:00pm in Greenville at the Regional Development Institute (Willis Bldg.) Reade & 1st Streets.
