Based on the CHPP, this would leave shell bottom, soft bottom, and wetlands as the remaining applicable fish habitats. Should other fish habitat focus areas be included in the monitoring strategy and if so, why? Would the recommended monitoring strategy (SAV and water quality) sufficiently capture trends that can be linked back to APNEP actions? Q2: What are the corresponding geographic areas for the monitoring strategy? Q3: Is this doable? Q4: What kinds of expertise are we lacking and/or need to grow in order to effectively address APNEP priorities and needs? How do we most effectively recruit that expertise? Q5: What emerging issues for the APNEP region does the STAC need to place focus on? How do we effectively engage STAC members to take ownership of those issues and produce white papers and other documents that can help progress our understanding?
